One Month Membership - \$25 (one dog) \$35 (two dogs)

Day Pass - \$10 (one dog) \$15 (two dogs)

*Membership Passes must be in the handler's possession.

*Park is closed from 8AM-10AM and 2PM-4PM daily for Conway Area Humane Society use.

*No more than two dogs per handler.

*No children under 12 are allowed in the dog park.

*All dog members must have a current rabies and DHLPP vaccines on record at CAHS.

*All dogs visiting the dog park must be spayed or neutered.

*No puppies under the age of 6 months allowed at the park.

*Understand and agree to abide by the dog park regulations as stated in the etiquette guide.

*Reported incidents will be reviewed and possible actions include, but are not limited to:

*Restricted use of the park;

*Meetings with our dog park socialization volunteers; and/or

*Terminated membership(s)

The Conway Area Humane Society Dog Park is not supervised by any agent or employee of CAHS. Use of this facility is at your own risk. By using this facility, you agree that you understand and assume all responsibility and liability for the risks of unleashing your dog(s) in this area.

Release and Hold Harmless Agreement

In addition the undersigned agrees to indemnify and hold harmless CAHS and all of its' employees, volunteers, staff, personnel, officers, and directors from any claims which may be made against them arising from the use by the undersigned or any person or animal brought onto the premises by the undersigned, of the Conway Area Humane Society Dog Park and CAHS. In addition, the undersigned hereby agrees to be personally responsible for any damage of any type caused to the Park or any portion of the CAHS property by use of the undersigned or any other person or animal brought upon the property by the undersigned.
